4) 英国のeVisaのNTL申請書類としてのNI Contribution Recordの有効性

Evidence to prove your continuous residency in the UK since becoming a permanent resident includes following documents

- * Council Tax letters
- * letter(s) from a GP confirming dates of attendance
- * letter(s) from a school or college confirming dates of attendance
- * electricity, gas or water bills
- * letter(s) from employer(s) confirming employment

英国のNI Contribution Recordは英国に継続して居住していた事の証拠書類の例には挙げられておらず、その有効性は疑問（？）

その理由は、英国のNI Contributionは例え英国の居住者で無く、外国居住者でも自身の英国のState Pensionの金額を増やす為に支払い可で有るのが理由か
